2. For any corrections, the School is accountable to pay the necessary extra fees towards issue of any revised certificates after receiving Statement of Grades/Marks.

3. The Result kept under Reserved Category

A - for Non availability of Practical Examination Marks

B - for Non submission of grades.

C - for Malpractice cases.

D - for Not attending discrepancies in Sports Marks/Internal Assessment Marks

4. ONLINE APPLICATION TO APPLY FOR VERIFIED PHOTOCOPY/RE-EVALUATION OR VERIFICATION OF MARKS IN ABSENTIA

a. The Portal (gbshse.gov.in/www.gbshse.net) will be opened for the above from 30/07/2020.

b. **Schools are required to pay the fees through PAYMENT GATEWAY provided on the Goa Board Website.**

c. The prescribed fees/date schedule is as follows:

1.	Verified Photocopy of the answer-books	Rs.350/- per subject	31/07/2020	01/08/2020 & 03/08/2020
2.	Verification of Marks in Absentia	Rs.75/- per subject	08/08/2020	10/08/2020 & 11/08/2020
3.	Re-evaluation of answer-books	Rs.700/- per subject	08/08/2020	10/08/2020 & 11/08/2020


- d. **Please Note:** If candidate applies for Verified Photocopy and/or Re-evaluation he/she is not permitted to apply for Verification of Marks in Absentia.
- e. The Head of Institution should categorically inform the candidates that in case of Verified Photocopy, totaling of marks and any unassessed answer will be verified.

However candidate may apply for Re-evaluation if desires after obtaining photocopy before the lapse of last date for Re-evaluation.

Please Note: Merely applying for Photocopy of answerscript will not absolve for facility of Re-evaluation.

- f. **No candidate will be permitted to apply for Verified Photocopy/Verification in Absentia/Re-evaluation of answer-book beyond the dates specified in this Circular.**
- g. **Parents should not visit this office for any type of discrepancies pertaining to assessment of answer-books. However they may route their request through Head of the Institution via email.**
- h. Statement of Grades/Marks of April-May 2020 S.S.C. Examination shall be made available after **6th August 2020**.
- * Passing Certificates of April-May 2020 S.S.C. Examination shall be made available at later date.
- * No separate intimation will be sent regarding declaration of result on the official website of this office.
- * Report of Verification in absentia and scanned copy of verified answerbooks (under Verified Photocopy of the answer-books) alongwith report will be made available through email to the Schools..
- * Result of Re-evaluation of answer-books/Verification of Marks in Absentia and Verified Photocopy of the answer-books will be uploaded on official Website of this office.
