INSTRUCTIONS FOR ENROLMENT AS A PRIVATE CANDIDATE FOR SSC/HSSC EXAMINATION

- 1. The application form for enrolment as a private candidate for SSC/HSSC examination shall be filled in by the candidate in his/her own handwriting.
- 2. The application duly completed in all respects shall be submitted with requisite enclosures and payment to the office of the Board within the prescribed dates.
- 3. The following enclosures shall be attached to each application: -
 - (a) Certificate from the Magistrate that he/she has been a resident of the State for a period of not less than two years prior to the date of commencement of the SSC/HSSC Examination at which he/she desires to appear
 - (b) Birth certificate or an affidavit on a stamp paper sworn before a Magistrate staring the actual date of birth and that his / her birth in not registered in any birth registration office and that he/she has not attended any recognized school.

OR

(b) The Original School Leaving Certificate of the recognized school last attended.

OR

- (b) The Duplicate School Leaving certificate from the recognized school last date attended with an affidavit on a stamped paper sworn before a Magistrate that the applicant did not join any recognized secondary school subsequent to the date of his/her leaving the school as shown in the Duplicate Leaving Certificate.
- (c) If required, the candidate shall produce the certificate from the head of the recognized School that he / she was not on the roll of the school during the academic year preceding the date of examination for which he / she desires to appear
- (d) The candidate shall offer subjects as per current scheme of examination.
- (e) The candidate shall produce a certificate signed by the Head of the recognized secondary school stating that the applicant is allowed to perform the practical work / experiments in Science (Regular & CWSN) and Geography (CWSN) for SSC examination in the said school, shall be submitted at the of application for enrolment.
- (f) The candidate shall submit a certificate signed by the head of the recognized secondary school stating that Practical work in the subject is completed by the

candidate to be submitted to the External examiner at the time of conduct of Practical examination by Goa Board of Secondary & Higher Secondary Education, failing which candidate shall not be allowed to answer Practical examination.

4. The fees prescribed for enrolment as a private candidate for SSC / HSSC Examination is a given below:-

The applications received after the prescribed dates shall not be accepted except in geruine cases, with the approval of the Chairman with late fees as prescribed.

The enrolment fees shall be paid by the candidate only once i.e. during enrolment as a private candidate.

- 5. Incomplete applications in any respect shall not be accepted.
- 6. The applications shall forward the application by the due date together with the required documents in ORIGINAL with attested copies thereof and necessary fees.
- 7. The Enrolment Certificate for March Examination may be collected from the office of the Board by the 5th November along with the original documents except 3 (b)
- 8. On scrutiny of each application, if the candidate is found ineligible to appear as a private candidate for the SSC/HSSC Examination as per the conditions laid down in the relevant rule quoted below or if the application is found to be incomplete in any respect, the enrolment fees paid shall be refunded to the candidate a s per rules.
- 9. The candidates should approach the office of the Board for any other information regarding course of studies, syllabi, text-books, examinations, etc.
- 10.If the school last attended by the candidate is situated outside the jurisdiction of this Board, then the School Leaving Certificate / Transfer Certificate (original or duplicate) shall be countersigned by the concerned Education Inspector producing the same to this office.
- 11. The instructions regarding submission of applications for admission to SSC/HSSC Examination shall be sent to the candidates at their first attempt as a private

- candidate. Theses instructions shall be available in the office of the Board for other private candidate appearing for subsequent attempts.
- 12. To submit online forms for admission to SSC / HSSC Examination the last dates should be tracked from official website of this office under Circular for Calling of Application SSC/HSSC.

HALL TICKETS may be collected from this office by JANUARY END.

Relevant rules from the Goa Secondary & Higher Secondary education (Almendments) Rules, 2001 (Rule No. 17 & 18)

Eligibility of Private candidates for SSC/HSSC Examination -

- (1) A person who has pursed specified course of studies privately and has completed the practical work prescribed for Std. VII to X in any recognized Secondary School at the time of application for examination (SSC) shall be admitted to secondary school / Higher Secondary School certificate examination and as a private candidate subject to the fulfilment of the following conditions-
- (a) He/ She has been a resident of the State of Goa for not less than two years prior to the date of commencement of SSC / HSSC Examination for which he/she desire to appear
 - However the deficiency, if any, in the period of two years residence in the State of Goa may be condoned by the Chairman on genuine ground.
- (b) He/ She was not on the roll of any recognized Secondary School / Higher Secondary school of the State during the academic year preceding the date of examination for which he / she desires to appear.
- (c) He / She must have completed the age of 17 years (SSC)/ 19 years (HSSC) not late than the 1st March of that academic year case of examination to be held in March. The date of birth declared by him / her in the form of application shall be supported by authentic document.
- (d) Not withstanding anything contained in (a), (b) and (c) above.
 - (I) A candidate being a citizen of India who has been a regular student of a Secondary / Higher Secondary School overseas and who has completed the course of studies for an examination equivalent to the Secondary / Higher Secondary examination of this Board may be permitted to appear at SSC/ HSSC Examination as a private candidate.

A candidate sent as a regular student (i.e. after having undergone the (ii) specified course of studies and kept the specified minimum attendance at a recognized institution) but failing at the corresponding examination equivalent to corresponding SSC / HSSC examination of this Boards, may be permitted to appear at the examination as a private candidate provided that such a candidate has not joined any Secondary / Higher Secondary School since his / her failur at the other examination concerned. Provided that it shall be competent for the Board to debar an applicant involved in malpractices to secure permission to appear at the examination as a private candidate under clause (1) above, from applying for permission to appear for the examination, for a period of two years from the month and year of the Examination for which permission is sought, even if such a candidate is other wise eligible and further forfeit the enrolment fee if already paid and cancel the enrolment certificate, if already issued

- (2) A person who has pursued his/ her studies and fulfilling above conditions shall apply to the Board in specified form along with specified fees and relevant documents to enroll himself / herself as a private candidate
- (3) The application shall state in writing t that he / she is not undergoing rustication imposed by any statutory Board of examination or University in India or any other examination authority at the time of submission of application for enrolment
- (4) An enrolment certificate shall be issued by the Board to a person eligible to appear for SSC/ HSSC Candidate.
- 5) The person who has been enrolled as a private candidate for SSC/HSSC examination shall apply for admission to the said examination in specified from along with the required documents and the fees specified by the Board.
- (6) The person who has been enrolled as a private candidate shall be exempted from offering school assessment based subjects for SSC/ HSSC examination
- (7) The private candidates shall not be eligible for award of prizes or scholarships.

19. Refund of enrolment fees of private candidates:-

A refund of 50% of an amount of enrolment fees paid along with application for enrolment shall be given to the candidates if the enrolment is rejected on geniuine grounds by the board.
