1. It is informed to verify the following entries in the result sheet of S.S.C. Examination of **SEPTEMBER - 2020** of the candidates sponsored by your institution. The same may be downloaded from the portal.

- * Name of the candidate/Mother/Father
- * Date of Birth
- * Subjects offered by the candidate.
- * Exemptions if any claimed by the candidate.
- * Name of the Centre.
- * Result (Specially if 'Pass' remark is printed by error when less than minimum marks for passing or absence is recorded in any subject).
- * Grade.
- * Facsimile signature of the Secretary of the Board.

2. For any corrections the Head of Institution shall be accountable to pay the necessary extra fees towards issue of revised marksheet after receiving Statement of Grades/Marks.

3. The Result kept under Reserved Category
A - for Non availability of Practical Examination Marks
B - for Non submission of grades.
C - for Malpractice cases.
D - for Not attending discrepancies in Sports Marks/Internal Assessment Marks

4. ONLINE APPLICATION TO APPLY FOR VERIFIED PHOTOCOPY/REEVALUATION OR VERIFICATION OF MARKS IN ABSENTIA

- a. **The Portal (www.gbshse.net/gbshse.gov.in) will be opened for the above from 09/10/2020.**
- b. **Schools are required to pay the fees through PAYMENT GATEWAY provided on the Goa Board Website.**
- c. The prescribed fees/date schedule is as follows:

SR No	PARTICULARS	FEES	LAST DATE
1.	Verified Photocopy of the answer-book	Rs.350/- per subject	12/10/2020

2.	Re-evaluation of answer-books	Rs.700/- per subject	19/10/2020
3.	Verification of Marks in Absentia	Rs.75/- per subject	19/10/2020

- d. If candidate applies for Verified Photocopy and/or Re-evaluation he/she is not permitted to apply for Verification of Marks in Absentia.
- e. However candidate may apply for Re-evaluation if desires after obtaining photocopy before the lapse of last date for Re-evaluation.
- f. **Please note: Merely applying for Photocopy of answer script will not absolve for facility of Re-evaluation.**
- g. **No candidate will be permitted to apply for Verified Photocopy/Verification in Absentia/Re-evaluation of answer-book beyond the dates specified in this Circular.**
- h. **Parents should not visit this office for any type of discrepancies pertaining to assessment of answer-books. However they may route their request through Head of the Institution via email.**
- * Statement of Grades/Marks of September 2020 S.S.C. Examination shall be made available on **10/10/2020.**
- * No separate intimation will be sent regarding declaration of result on the official website of this office.
- * Report of Verification in Absentia and scanned copy of verified answer-books (under Verified Photocopy of the answer-books) alongwith report Will be made available through email to the schools.
- * Upon receiving report the same may be collected as per the date specified in the report.
- * **No result will be handed over to the candidate/s or parents even after producing authority letter from the school.**
