Sir/Madam,

In partial Modification to the above referred Circular No.41, dated 05/08/2021, Board has decided to give following options in respect of **Repeater Candidates registered for March-April 2020-2021 SSC & HSSC Examination only:-**

1. **The Board shall declare the result of the Repeater Candidates registered for March-April 2020-2021 SSC & HSSC Examination based on Internal Assessment Scheme** as per circular No.21, dated 01/06/2021 & Circular No.29, dated 25/06/2021 for SSC & HSSC Candidates respectively.

And

2. **Pending the declaration of the said result, an option is given to these repeater candidates to appear for the Supplementary Examination for HSSC & SSC** as per Circular No.41 dated 05/08/2021 so that they can avail the benefit of already scheduled supplementary examination.

- ❖ The one time measure has been taken in the backdrop of cancellation of the main examination vide circular No.20, dated 24/05/2021 and Circular No.22, dated 03/06/2021, in keeping the safety of Examination personnel and candidates on paramount.
- ❖ In view of the above, Head of Institutions concerned are requested to take steps so as to reach marks in Option 1 in Excel file as per Annexure - II attached to circular No.41, dated 05/08/2021 by 21st August 2021 and Marks in Option 2 by 30th August 2021 positively.
