Sub: Class IX & XI Needs Improvement Students of the Academic Year 2020-2021 to appear as Private Candidates for Class X & XII Public Examination 2021-2022.

Sir/Madam,

- ❖ The Matter of enrolment of students of Class IX & XI with Needs Improvement Remark of the Academic Year 2020-2021 as Private Candidates was under consideration by the Board. The same matter was extensively deliberated in the Annual General Body Meeting of the Board and it was decided to invite suggestions from General Public and Stake Holders to place before the Committee constituted for the purpose.
- ❖ The suggestion received from Public regarding the above cited subject were placed before the Committee Constituted to decide on whether to allow Needs Improvement Students of Class IX & Class XI of the Academic Year 2020-2021, to appear as Private Candidates in the ensuing Public Examination 2021-2022 for Class X and Class XII respectively. After extensive deliberation it is decided as follows:-
 - i. To allow Needs Improvement Students of class IX & XI of the Academic Year 2020-2021, to appear as Private Candidate irrespective of age in the ensuing Public Examination 2021-2022 for Class X and Class XII respectively as a one-time measure in view of Covid-19 Pandemic situation. Further, Class XI Needs Improvement Students can appear as Private Candidates only in non Practical subjects.
 - ii. For registration as Private Candidate, option may be given to the Student to choose any school of their choice or can choose their respective school.
 - iii. Board will pay 60% of enrolment fees of the Private Candidates as token of appreciation to concerned schools to cater to the needs of these Private Candidates.
 - iv. The enrolment fee is ₹800/- and scrutiny fee is ₹400/-.
 - v. The Schools opted by the students to register as Private Candidates shall provide them with study material and necessary guidance on voluntary basis and conduct Internal Assessment and send Marks to the Board for further needful action.
