Sub:- Regarding uploading of marks obtained by the candidates in First Term Examination December-January 2021-2022 of HSSC and SSC Exam.

Sir/Madam,

- ❖ It is informed that the marks obtained by the candidates in First Term Examination HSSC and SSC December-January 2021-2022 have been uploaded on school portal. The entire process has been completed. The same may be downloaded from the School portal and may please be intimated to the candidates concerned.
 - ❖ There is **no separate passing** for First Term and Second Term Exam. All concerned are informed that passing criteria is as per circular No. 19, dated 25/04/2012.
 - ❖ The schools shall take care that no OMR based subjects are selected for re-evaluation.
 - ❖ TO APPLY FOR VERIFIED PHOTOCOPY/REEVALUATION OR VERIFICATION OF MARKS IN ABSENTIA ONLY ONLINE APPLICATION WILL BE ACCEPTED.
- a. The Portal (www.gbshse.net /gbshse.gov.in) will be opened upto 10/03/2022.
- b. Schools are required to pay the fees through PAYMENT GATEWAY provided on the Goa Board website.
- c. All request for verification shall be sent in one lot by the school.
- d. The prescribed fees/ date schedule is as follows:
