  - Date of Birth.
  - Subjects offered by the candidate.
  - Exemptions if any claimed by the candidate.
  - Name of the Centre.
  - Result (Specially if 'Pass' remark is printed by error when less than minimum marks for passing or absence is recorded in any subject).
  - Grade.
  - Sports Merit Marks if any.
- ❖ For any corrections the Head of Institution shall be held responsible and is accountable to pay the necessary extra fees towards issue of any revised certificates after receiving Statement of Grades/Marks.
- ❖ The Result kept under Reserved Category
  - A - for Non availability of Practical Examination Marks.
  - B - for Non submission of grades.
  - C - for Malpractice cases.
  - D - for Non submission of Final Eligibility Certificate.
  - E - for Not attending discrepancies in Sports Marks/Internal Assessment Marks.

OR VERIFICATION OF MARKS IN ABSENTIA FOR SUPPLEMENTARY EXAM ONLY

- a. The Portal ([gbshse.gov.in](http://gbshse.gov.in)) will be opened for the above from The prescribed fees/date schedule is as follows:

| SR NO | PARTICULARS                           | FEES                  | LAST DATE  |
|-------|---------------------------------------|-----------------------|------------|
| 1.    | Verified Photocopy of the answer-book | Rs. 350/- per subject | 26/07/2022 |
| 2.    | Re-evaluation of answer-books         | Rs. 700/- per subject | 28/07/2022 |
| 3.    | Verification of Marks in Absentia     | Rs. 100/- per subject | 28/07/2022 |

- b. **Please note:** If candidate applies for Verified Photocopy and/or Re-evaluation he/she is not permitted to apply for Verification of Marks in Absentia.

- c. Schools are required to pay the fees through PAYMENT GATEWAY provided on the Goa Board Website.

- d. The Head of Institution should categorically inform the candidates that in case of Verified Photocopy, totaling of marks and any unassessed answer will be verified.

However, candidate may apply for Re-evaluation if desires after obtaining photocopy before the lapse of last date for Re-evaluation.

- e. No refund in case marks changed after re-evaluation.

- f. No candidate will be permitted to apply for Verified Photocopy/Verification in Absentia/Re-evaluation of answer- book beyond the dates specified in this Circular.

- g. Statement of Grades/Marks and Passing Certificates of June 2022 S.S.C. Examination shall be made available at later date.

- ❖ No separate intimation will be sent regarding declaration of result on the official website of this office.

- ❖ Verified Photocopy of the answer-book/Verification in Absentia report will be sent to the school through e-mail.
